ChildSafe is radically improving child safety across a range of organizations in Australia and New Zealand. The ChildSafe Safety Management System helps maintain high standards, both with the appointment and training of those who work with children and young people, and the risk management of programs and activities carried out by those organizations. That's why the by-line is "Safe People/Safe Programs".



Children need our protection. ChildSafe is a harm prevention charity set up to help organizations deliver that protection.

Alongside a set of resources designed to deliver codes of practice, standards of safety, training packages and systems of management, ChildSafe has developed a unique compliance tool—**Safety Management Online**—so that everyone at every level of an organization can have online access 24/7.

The online system tracks people's appointment and training. It provides a framework for the safe planning of programs and the granting of 'permission to proceed'. It even provides online training, along with an extensive range of templates and resources.

The Mission

ChildSafe is a Harm Prevention Charity, promoting the prevention and control of behaviour that is harmful or abusive to children and young people when in the care of an organization.

The desire to protect and care for children and young people is the fundamental motivation.

Sources of Income

ChildSafe relies on two sources of income:

- Funds generated from the sale of resources and online subscriptions
- Donations and grants from individuals and groups who value the safety of children and young people

The pricing of resources is kept low to make ChildSafe affordable to those who most need it. Many of the organizations who run programs for children in our communities are volunteer-based and struggle to fund their programs.
